INTRODUCTION

The Society of King's Inns and its records - Historical introduction.

So much has now been written on the history of the King's Inns (see especially D. Hogan: "The Honorable Society of King's Inns" and "The Legal Profession in Ireland, 1789-1922") that a brief outline of its origins and development as an introduction to the records is all that is required here.

16th Century

Although there are accounts pointing to the existence of an Irish Inn of Court during the reign of Edward I, the origins of the Society of King's Inns can be reliably traced only to the time of Henry VIII, when English law became current throughout the whole kingdom and a demand arose for "persons knowing the law". Perhaps with the model of the English Inns of Court in mind, a number of judges and senior lawyers petitioned the Privy Council for a grant of land where they could establish a settled place of meeting during term time. In 1542, King Henry VIII demised to John Allen and the "other Professors of the Law" the lands of the recently dissolved monastery of Friars Preachers, which lay on both sides of the river Liffey, for a term of twenty one years. The lawyers established their Inn on part of the monastery's property on the north bank of the Liffey (the site of the present Four Courts on Inns Quay) and adopted the title King's Inn in recognition of the royal grant. At the same time, the King introduced the requirement that persons wishing to be admitted to practise at the Irish Bar should first have attended at one of the English Inns of Court (which hitherto had been virtually closed to Irish students). The lease of land was renewed by Queen Elizabeth and the statute enforcing residence at an English Inn was made perpetual. (The requirement was only abolished in 1885.) Despite the renewal of the lease, the Society seems to have thereafter entered a period of decay. The Courts of law were removed there in 1582 from Dublin Castle but, by the end of the century, the buildings had fallen into a ruinous condition.

17th and early 18th Centuries:

In 1607 the "Judges and Practisers" persuaded the Lord Deputy, Sir Arthur *Chichester*, to assist in the restoration of the Society, and he, along with the judges and senior members of the Bar, was enrolled in the "Book of Admittances". This latter, known as the "Black Book" or "Liber Niger" of the King's Inns, is the earliest extant record of the Society in the archives and contains admissions, accounts and Council minutes from 1607-1730. [B1/1]

The revival was followed by a renewal of the grant of lands, in 1611, when King James I granted the lands to Sir John Davies, the Attorney General, for the judges and other lawyers, to be used as a "common Hall for ever". This was confirmed by King Charles I in 1637 [G1/1] probably to defeat the claims of the Usher family to the property. [G1/4 – "Brown Book"]

At first, membership of the Society was voluntary but, from c.1629, membership became compulsory for practising barristers and, from the early 18th Century, for attorneys and solicitors. The governing body of the Society was the Council, composed of the "Bencher" - the Lord Chancellor, judges and senior members of the Bar. The main function of the Council was the regulation of admission to the legal profession, while other functions related to the appointment of the Treasurer and other officers, discipline of barristers, leases of property and approval of building works [see B - Council]

18th Century:

During the late 17th and early 18th Centuries, the Society again entered a period of decay and, in 1730, the House of Lords committee appointed to report on the state of the Public Records "found the whole building of the Inns in a decayed, ruinous state." According to a report of a Committee of Benchers in 1808, the Judges and Professors continued to reside there until 1742 when, "the houses and buildings of the Society became in a very ruinous state, and the professors of the law ... removed to other parts of the city; from which period the ancient property and buildings of the Society, on the Inns Quay, was for a considerable time neglected." [B3/1/1] In 1751, a private Act of Parliament was passed enabling the Society to sell or lease their lands at Inns Quay. A draft of this Act, prepared in 1743, is preserved in the Archives [G1/2] and testifies to the ruinous condition of the buildings.

For some time the government had sought a suitable site for the new Public Offices and Law Courts and the Society's grounds on Inns Quay were proposed. In 1757 the Surveyor General was appointed to examine and survey the ground and to treat with the Society. The land was surveyed in 1757 and 1758 and a plan drawn up. [see the Admission Book, which also contains Council Minutes for 1758 J1/3, and the book of notes explaining the design for the "Publick Offices", dated 1758 H1/1/1] The House of Commons approved the site in 1762 and, according to the Benchers' report of 1808, referred to above, "in 1776, before any thing final was concluded upon, the servants of the Crown ... took possession of the said ground of the Society on the Inns Quay, and in the same year, began to erect the present western range of law offices therein." The Benchers' minutes record that various applications were made to the government for rent or other compensation. [B1/6/1] The public offices were designed by Thomas Cooley, while James Gandon was commissioned to design the new court building which was commenced in 1786 and completed in 1796. A book of receipts for public money used in the construction of these buildings is preserved in the Archives. [H1/1/2]

Late 18th Century - early 19th Century:

Temporary locations were found for the Society, among them the Music Hall in Fishamble Street [B1/6/1], and, in 1792, premises were taken for a dining hall and library in Townsend Street [B1/6/1 and G1/3] which were finally surrendered in 1798. Several sites were examined for the construction of a permanent Inn of Court until finally a piece of ground in the Constitution Hill/Henrietta Street ar-

ea was chosen and leases taken out in 1793 and 1794. An Act passed in 1798 enabled the Dean and Chapter of Christ Church, Dublin, to grant the grounds to the Society and, consequent on this, the property was granted for ever. Gandon was commissioned in 1800 to design a library, dining hall and chambers for the members of the Society, and work on the dining hall was commenced that year. The building works proceeded slowly, Gandon resigned in 1808, and the work on the north wing was finally completed in 1817, under his pupil, Henry Aaron Baker. [B1/6/1; H1/1/5]

Finding it too costly to complete the building according to the plans, the Benchers agreed to hand over the unfinished part to the Crown as a depository for public records. By an Act passed in 1814, part of the property was vested in the Crown and the building when completed became the Registry of Deeds. [H2/5]

Plans for the construction of Chambers were prepared in 1826 by Frederick Darley [H4/2] but were never proceeded with. The same architect was commissioned to design the new Library building in Henrietta Street, beside the main building, and this was completed in 1830. [B1/6/3; H4/1]

The latter half of the 18th Century saw a period of reorganisation for the Society when a number of statutes were passed and Benchers' rules introduced regulating admission to the legal profession. Statutes regulating apprenticeship to the solicitor's profession were passed in 1733 and 1773, while a Benchers' regulation in 1779 decreed that applicants for admission to the degree of Barrister-at-Law should first have kept 8 terms commons in one of the London Inns. An Act passed in 1782 declared that "no person shall be admitted to the degree of barrister at law ... until he shall have duly qualified himself for the same", and required candidates to have been registered as students for 5 years and to have kept 12 terms Commons (4 in Dublin). Further regulations were passed in 1783 and 1789, and, in 1792, at the request of the Benchers, a Royal Charter was granted to the King's Inns which confirmed to the "Professors of Law" their ancient franchises, liberties, powers and privileges and incorporated the Society with the Benchers as its controlling body. The Charter was confirmed by an Act of the Irish Parliament in 1792 [A1/1] but was immediately opposed by the members of the Bar [A1/3] who demanded its repeal. A petition by the Benchers in 1793 led to the repeal of the confirmatory Act and the surrender of the Charter later that year. [B1/6/1]

In 1792 draft Rules for the regulation of the Society had been printed and distributed [A2/1] and these were adopted by the Benchers in 1793 [A2/2; B1/6/1] and published and distributed in 1794.

The Preamble to the Rules declared –

"We, the Benchers of the said Society, having full power and authority to make and ordain Rules and Orders, for and concerning the business and practise of Attorneys, and for their admission into the said Society, as Members thereof; and for and concerning the admission of Students into the said Society; and for and concerning their being generally admitted into the said Society, and to ranks and degrees therein; and for the advancement of Knowledge in the science and practise of the Law; And being convinced of the importance of the trust committed to us, and that the Safety and enjoyment of the Persons, Property and Characters of the Inhab-

itants of this Kingdom greatly depend upon the knowledge and integrity of those who are permitted to profess and practise the science and business of the Law. And conscious that as the grant of that permission is entrusted to us, the reproach and crime will both be ours, if at any time we shall admit into this Society, through fear, favour, or affection, or slightly or unadvisedly, any improper or incapable person, or finding him grossly such, shall suffer him to continue therein..."

The Rules covered the taking of apprentices, admission of students and barristers, payment of fees, keeping of Commons and building of Chambers.

19th Century - 1926:

The main developments of the 19th and early 20th Centuries, as seen through the records, were:

- (1) Reform of legal education;

- (2) Foundation of the Law Society and the subsequent control by that Society of the solicitors' branch of the profession;
[see K - Attorneys, Solicitors and the Law Society, B1/6 (4-10) - Benchers' Minutes 1830-1917, B3/2/3, B3/3/1+2, B3/4/4 - Committee reports.]
- (3) Building works at the Four Courts involving the Law Library, solicitors' buildings and additional courts offices, and the Benchers' compensation claim following the burning of the Four Courts in 1922;
[see H1 (2-5) - Buildings - Four Courts, B1/6 (2-5, 7-10) - Benchers' Minutes 1804-1901.]
- (4) Building and decorating works at the King's Inns and the King's Inns Library;
[see H2/1 - Buildings -King's Inns, H4/2 – Buildings King's Inns Library.]
- (5) Inquiries into conduct of barristers and disbarments etc.,
[see J4 -Discipline inquiries and disbarments.]
- (6) Adoption of new Rules [A2/3]; Library administration and appointments to offices of Librarian and Assistant Librarian [B1/6/2, (5-8); B2/1/1; B3/2/1; F1/1 and M]; Barristers' Bill (1885) [B1/6 (9-10)]; Investigations into finance with recommendations as to reductions required [B1/6/10+11; B3/1/1+2, B3/2/5]; Special concessions for students on active service in the Great War [B1/6/11+13; Establishment of a separate Inn of Court in Northern Ireland (1926)].

2. The Records of the Society

When this survey was commenced, in January 1988, the records were stored in a number of different locations within the Library building, the vast majority being held in tea chests in the Record Room. The initial objectives of the survey were (1) to locate and note the major groups and record types, and (2) to examine their physical condition and make recommendations for their preservation and conservation. An inventory of all the manuscript volumes was first drawn up, and from this a scheme of arrangement was worked out, based on the structure and functions of the Society, as revealed by the published material and the volumes themselves. Then the documents packed into the tea chests were removed, surface cleaned, examined and sorted into groups. Some papers were tied together in bundles, and these were kept in their original arrangement, but the majority consisted of separate items which had simply been stuffed into the boxes at various times. These included

printed reports, architectural plans and drawings, bills and receipts, deeds, leases and conveyances, account books, correspondence, maps, notebooks, diaries etc. The admission papers had been examined by the editors of "King's Inns Admission Papers (1982)" and the papers for the period 1723-1867 arranged in alphabetical order and indexed.

It soon became obvious that, although some series of records were complete (Benchers' Minute Books, Library Committee Minute Books etc.), the records preserved in the Library represented but a fraction of what must have originally existed. It is known that the admission papers were kept in the Tholsel until 1804 and that many were lost in the course of their transfer on open carts to the King's Inns. It is also known that when Duhigg came to write his History (published 1806) many of the records had already disappeared. As to when and how the extant records came to be housed in the Record Room, little is known. Some were in a very poor physical condition but the majority were in a reasonably fair condition considering their manner of storage.

In the autumn of 1988, the Record Room was completely refurbished and steel shelving installed. The records were subsequently stored in archival boxes and further grouped and arranged. The majority have now been listed and numbered but, as there are still some series requiring further examination and listing, amendments may have to be made to this arrangement and list on final completion of the work. In addition, some more recent records were deposited in the archives after the completion of the survey, and, though noted in this list, will also require more detailed examination.

3. Research use of the collection

The records preserved in the King's Inns Library are not only a valuable source of research for the history of the Society and its buildings, and the history of the legal profession and the law in Ireland, but would also prove of interest to students of social, economic, local and architectural history. In recent years, much work has been done on the history of the Society, based on the records (notably the publications of D. Hogan and T. Power listed below) and it is to be hoped that this survey and guide will open the way for even more studies and publications, as well as helping in their future preservation.

Between 1838 and 1841 he was the editor of the Newry Examiner. In 1840 he removed to Dublin, becoming an Irish Queen's Counsel in 1849. In 1860 he was appointed Solicitor-General for Ireland and Attorney-General in the following year. In 1865 he was appointed a judge of common pleas, and in 1868 became Lord Chancellor of Ireland in William Ewart Gladstone's first ministry. O'Hagan was the first Roman Catholic to hold the chancellorship since the reign of James II, an Act of Parliament admitting Roman Catholics to the position having been passed in 1867. In 1870 he was created Baron O'Hagan, of Tullahogue in the County of Tyrone, and held office until the resignation of the ministry in 1874. In 1880 he again became Lord Chancellor on Gladstone's return to office, but resigned in 1881.
